Top Line Talking Point

This is a **BAD** bill.

Universal vouchers and Educational Savings Accounts will do nothing to improve educational outcomes for most students who attend these schools, will defund the public schools that are the overwhelming choice of parents, and most of the voucher money will go to students already in private school.

Supporting Facts & Data

- 61% of students who go to voucher schools return to public school within two years.
- The average student loses a year of learning after two years at a voucher school.
- Over 85% of families choose to send their students to public schools. Almost 80% of students go to their neighborhood public schools.
- Neighborhood public schools are underfunded. Florida ranks 48th in public education funding, and funding for Florida's public schools is down 17.5% in inflation adjusted dollars since 2007.
- In states where similar programs have been implemented, 80% of taxpayer money goes to families who are already paying for private school tuition.
- Voucher amounts will not pay the full tuition cost of the prestigious private schools that families imagine their student can attend. Prestigious private schools do not need to admit students who receive vouchers.
- Most voucher schools are strip mall school with unqualified teachers, workbooks instead of rigorous curriculum, and no wraparound programs or services.
- Step Up for Students, the organization that will administer this program, failed horribly at administering MacKay and Gardiner program vouchers for students with disabilities, resulting in students who did not receive needed services.
